Sub: Strict implementation of time limits and noise levels for bursting fire crackers on Diwali regarding.

- 6. According to the Constitution, no one has the right to harm the public by violating the human right to live peacefully in their homes.
- 7. As per the directions of the Hon'ble Supreme Court and G.O.(Rt)No.3025/2024/HOME Dated, Thiruvananthapuram, 18-10-2024 of the State Government, the time limits prescribed for bursting firecrackers on Diwali is **8pm to 10pm only**, and also only the **green crackers** are to be permitted (Ref-1).

8. As per the Noise Pollution (Regulation and Control) Rules, 2000 of the Environment (Protection) Act, 1986, responsibilities are vested with CPCB and SPCBs to make sure "The noise levels in any area/zone shall not exceed the ambient air quality standards in respect of noise as specified in the Schedule." As follows: -

Area Code	Category of Area	Day Time	Night Time
A	Industrial Area	75dB	70dB
В	Commercial Area	65dB	55dB
C	Residential Area	55dB	45dB
D	Silence Zone	50dB	40dB

- 9. As per the G.O.(P).No. 111 /2002 Dated 29th July,2002, Thiruvanthapuram. "In exercise of the powers conferred by clause (c) of rule 2 of the Noise Pollution (Regulation and Control) Rules, 2000 read with sub-rule (2) of rule 4 thereof the Government of Kerala hereby designate, the District Magistrates, the commissioners of Police/the Superintendents of Police and the Deputy Superintendents of Police (Sub Divisional Officers) as the authorities under the said rules for the maintenance of ambient air quality standards in respect of noise pollution within their respective jurisdiction in the State." (Ref-2)
- 10. But the rules are being violated frequently in the <u>residential areas</u>, as the designated authorities (Ref-2) are not taking any action against the polluters.
- 11. Last year, even after many complaints along with videos submitted to the Government and the Police, there was absolutely no action against the polluters even though they bursted firecrackers in front of my house at midnight. Thumba Police should identify the polluters (Ref-5, Sl.No. 8, 9, 13, 15) and warn them in advance to prevent the illegal activity during this Diwali.
- 12. So it is humbly requested to take effective actions to implement the directions of the Hon'ble Supreme Court and the Hon'ble National Green Tribunal and ensure stringent action against the violators, and also to inform me as a senior citizen about the action taken before Diwali.

ORDER

As per the order read above, the Hon'ble Green Tribunal has issued the direction that the cities/towns where air quality is 'moderate' or below, only green crackers be sold and the timings for use and bursting of crackers be restricted to two hours during festivals like Diwali, Chatt, New Year/Christmas Eve etc. It is also directed that if nothing is specified by the State, timing will be 8 to 10 pm on Diwali and Gurupurb, 6 am to 8 am on Chatt and 11.55 pm to 12.30 am during Christmas and New Year eve.

- 2. The State Pollution Control Board as per the letter read above, requested to take urgent measures for controlling air pollution by restricting/regulating the use and bursting of the fire crackers during Deepavali festival. It is informed that in Kerala ambient air quality index of the cities/towns has not gone below 'moderate' category as per the monthly average data between September 2023 and September 2024 and hence usage and bursting of green crackers can be allowed for 2 hours with the specified timing of 8 pm to 10 pm, during the Deepavali festival.
- 3. Government have examined the matter in detail and ordered to restrict the timings for use and bursting of firecrackers for a maximum

of two hours, between 8:00 pm and 10:00 pm on Deepavali, and between 11:55 pm and 12:30 am on Christmas and New Year. It is further ordered that only the sale of green crackers will be permitted in the State.

4. District Magistrates and District Police Chiefs shall ensure strict compliance.

In exercise of the powers conferred by clause (c) of rule 2 of the Noise Pollution (Regulation and Control) Rules, 2000 read with sub-rule (2) of rule 4 thereof the Government of Kerala hereby designate, the District Magistrates, the commissioners of Police/the Superintendents of Police and the Deputy Superintendents of Police (Sub-Divisional Officers) as the authorities under the said rules for the maintenance of ambient air quality standards in respect of noise pollution within their respective jurisdiction in the State.

Explanatory Note

(This does not from part of the notification, but is intended to indicate its general purport)

As per sub-rule (1) of rule 4 of the Noise Pollution (Regulation and Control) Rules, 2000 the noise levels in any area/zone shall not exceed the ambient air quality standard in respect of noise as specified in schedule. Sub rule (2) of the said rule provides that the authority shall be responsible for enforcement of noise pollution control measures and the due compliance of the ambient air quality standards in respect of noise. As per rule 2(c) of the said rules authority means any authority or officer authorised by the Central Government or State Government as the case may be. At present no such authority has been appointed in the State for the said purpose. Therefore Government consider if necessary to designate the District Magistrates, the Commissioners of Police/the Superintendents of Police and the Deputy Superintendents of Police (Sub-Divisional Officers) as the authorities under the said rules to maintain and control ambient air quality standards prescribed under the said Rules.
